Economics

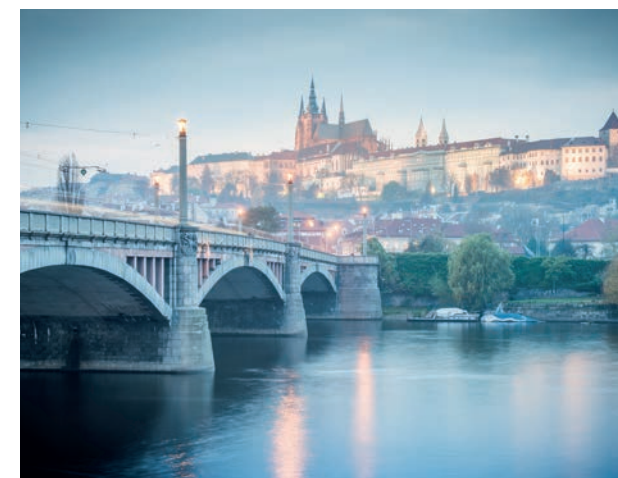
